Cushman Dam- Rebar is completed, concrete has been poured on the face of the dam, on the East Collings Ave side, takes approx. 28 days to cure. Sleuth gate will be installed shortly. Speaking with RD Zeulli, it should be completed by the end of this month or the 2nd week of March, pending weather.

Speaking with Pennoni, stated it could up to a month for Dam Safety to inspect and approve that we can put water in the lake, possibly April.

Lake George & Lake Albert, survey conducted last week(?) Audio interruption/feedback. Guardrails were removed to get equipment in to do boring and testing, Beth-Ann should have the results in the next 2 weeks. From what was said to Steve Slimm, Lake Albert Dam will be re-build, not a full replacement. Lake George will be an entire replacement including spillway same as Braddock Lake.
