General Meeting Minutes

Monday, April 1,2024

Call to Order

The meeting was called to order by Vice President, Donna Sutts. She asked everyone to stand for *The Pledge of Allegiance* to the Flag. The meeting was held at the Folsom Borough as well as Zoom.

Keegan Smith accepted the nomination for Tier 2 representative, Carol made a motion & Lynn 2nd, all board members by roll call accepted Keegan as our new Tier 2 representative.

Both Beth and Keegan were sworn in by Donna and are now part of the 2024 Board.

Reading and Approval of Minutes of previous meeting

March Minutes were 12 pages in length and Donna asked the board if we could make a motion to forego reading them. Keegan made a motion, Beth 2^{nd} , all board members by roll call voted yes.

Dams Update with Beth Grasso

Meeting at dam held on Good Friday with Contractor and some board members to discuss the progress of the dam building and were we are with it. DEP, resolve some minor issue- going into the punch list:

Rail around top of culvert

Soil erosion, stablizing the areas to try to gt some grass growing, spread some top soil. Close u the bypass system, get that over to the NJDEP. As discussed on Friday, ACB. Water will start to rise once the alternate spillway is gone. Then the DEP will come out and do their final inspection. Estimated timeline- possible end of May first week of June.
